

## Terms and conditions

### 1. Introduction

Thank you for using BmyGuest.

These terms and conditions are provided by BmyGuest ApS and covers your use of the application BmyGuest (hereinafter "the Application").

The Application is a cloud-based platform designed for the purpose of facilitating meetings and easing the registration process at companies. The Application is available for download on App Store and Google Play Store. Should you require information about how we process your personal data, you can read more about this in our Privacy Policy. ### 1. Use of the Application

If you are using our Application on behalf of the organisation of your employment and your organisation's administrator have created a user profile for you, your account is purchased and paid for by the organisation of your employment. Please note that your administrator might require you to follow additional rules.

Your administrator will not be able to access or disable your BmyGuest account.

For any use as a visitor, which is not related to or required by the organisation of your employment, this Application is provided to you for free.

In order to use the Application, you must agree to these terms and conditions, and you must be at least 15 years old.

As long as you comply with these terms and conditions, you will have a license to use the Application for attending and hosting meetings.

### 2. User obligations

As a user of the application, you are not allowed to:

- use the application in violation of applicable laws,
- use the platform in a way different than intended,
- impersonate someone else and use someone else's account,
- reverse engineering the application,
- distribute or sell any part of the application or create a product or service based on the application, including developing third party apps that interact with the application; or
- copy any content from the application.

When accepting these terms and conditions, you agree to being familiar with the fact that the use of the application may require a certain minimum compatibility standard in relation to your hardware and software. It is your responsibility to ensure that your hardware and software complies with such requirements, which may change over time.

All intellectual property pertaining to the application, any changes or improvements thereof, descends to and will remain with BmyGuest ApS, including the right to improvement, changes, redistribution and transfer of such Immaterial Rights.

### 3. Right to terminate account

If you are in breach of these terms and conditions, BmyGuest ApS reserve the right, in our sole discretion, to terminate your right to access or use of the Application. We are not responsible for any loss, damage or harm related to your inability to access or use the Application based on such termination.

#### **4. Warranty and limitation of liability**

You are responsible for the confidentiality of your username, password and account, including all activities on your account. You are also responsible for ensuring that the information you provide is correct.

The Application is delivered to you in the form that it is and exists, and BmyGuest ApS does not grant any direct or indirect guarantees that the use of the Application will be uninterrupted and free of any deficiencies. BmyGuest ApS also does not provide any warranty for software or products delivered by or on behalf of third parties.
